1040 Tax Organizer

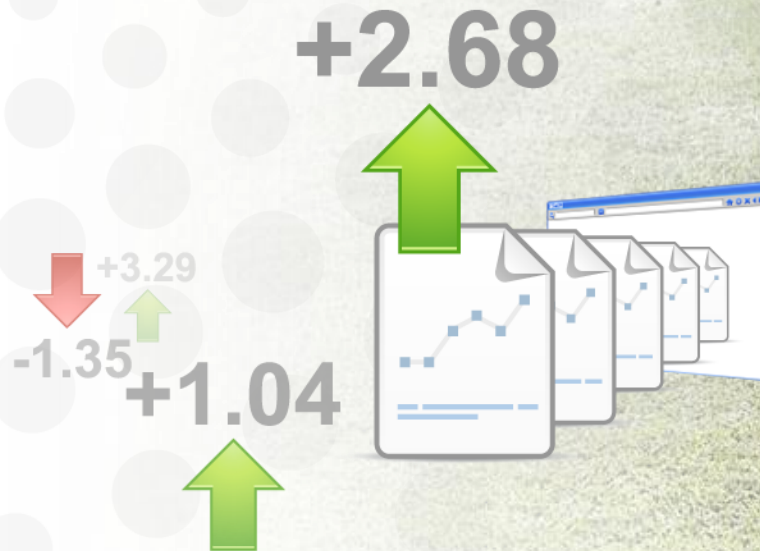
